Mayo Clinic on Aspirin -Dr. Virend Somers is a Cardiologist from the Mayo Clinic who is the lead author of the report in the July 29, 2008 issue of the Journal of the American College of Cardiology.

WHY KEEP ASPIRIN BY YOUR BEDSIDE?



If You Laugh at These Dark Jokes, You're Probably a Genius

"Magic beer," he says.

"Oh, yeah? What's so magical about it?"

Then he shows him: He swigs some beer, dives off the roof, flies around the building, then finally returns to his seat with a triumphant smile.

"Amazing!" the man says. "Lemme try some of that!" The man grabs the beer. He downs it, leaps off the roof —and plummets 15 stories to the ground.

The bartender shakes his head. "You know, you're a real jerk when you're drunk, Superman."

[dropcap]Let's[/dropcap] ignore for a moment whether or not that poor rube survived his fall (if it makes you feel better, let's say Trampoline Man was waiting for him on the ground). The real question is: Did you find this joke funny? Sick? Maybe a little of both?

According to a new study published in the journal Cognitive Processing, your reaction could indicate your intelligence. In the paper, a team of psychologists concludes that people who appreciate dark humor—defined as "humor that treats sinister subjects like death, disease, deformity, handicap or warfare with bitter amusement and presents such tragic, distressing or morbid topics in humorous terms"—may have higher IQs, show lower aggression, and resist negative feelings more effectively than people who turn up their noses at it.

To test this correlation between sense of humor and intellect, researchers had 156 male and female participants read 12 bleak cartoons from The Black Book by German cartoonist Uli Stein. (One of them, which paraphrases a classic joke, shows a mortician reaching deep into a cadaver as a nurse muses, "The autopsy is finished; he is only looking for his wrist watch.") Participants indicated whether they understood each joke and whether they found it funny, then took some basic IQ tests and answered questionnaires about their mood, aggressive tendencies, and educational background.

The results were remarkably consistent: Participants who both comprehended and enjoyed the dark humor jokes showed higher IQs, and reported less aggressive tendencies, than those who did not. Incidentally, the participants who least liked the humor showed the highest levels of aggression and the worst moods of the bunch. The latter point makes sense when you consider the widely-studied health benefits of laughter and smiling; if you aren't able to greet negativity with playful optimism, of course you will feel worse.

But what about the link to intelligence? According to the researchers, processing dark humor jokes takes a bit more mental gymnastics than, say, processing a knock-knock joke—it's "a complex information-processing task" that requires parsing multiple layers of meaning, while creating a bit of emotional distance from the content so that it registers as benign instead of hostile. That emotional maneuvering is what sets dark humor jokes apart from, say, puns, which literally pit your brain's right and left hemispheres against each other as you process a single word's multiple meanings, but usually don't force you out of your emotional comfort zone. Tina Fey sums up the difference pretty well: "If you want to make an audience laugh, you dress a man up like an old lady and push her down the stairs."





cold weather which caused sharks to freeze in the ocean and iguanas to drop out of trees.




You'd never guess from it that those regions had just experienced record-breaking cold, would you?

Homewood first smelt a rat when he examined the New York data sets.

He was particularly puzzled at NOAA's treatment of the especially cold winter that ravaged New York in 2013/14, which he describes here:

The cold weather really began on Jan 2nd, when an Arctic front descended across much of the country, and extended well into March.

The NWS wrote at the end of the winter:

The winter of 2013-14 finished as one of the coldest winters in recent memory for New York State. Snowfall across Western and North Central New York was above normal for many areas, and in some locations well above normal. This winter comes on the heels of two previous mild winters, making the cold and snow this winter feel that much harsher.

Temperatures this winter finished below normal every month, and the January through March timeframe finished at least 4 degrees below normal for the two primary climate stations of Western New York (Buffalo and Rochester).....

Relentless cold continued through the month of January across the region.

So why, he wondered, did NOAA have this marked down as only the 30th coldest winter (since 1895) on its New York State charts, with a mean temperature of 16.9F?

Homewood compared the local records for January 1943 and January 2014 – months which, according to NOAA's charts, had very similar average temperatures.

What he found was that NOAA's charts were deeply inaccurate. The 2014 local temperatures had been adjusted upwards by NOAA and the 1943 local temperatures downwards.

He concludes:

On average the mean temperatures in Jan 2014 were 2.7F less than in 1943. Yet, according to NOAA, the difference was only 0.9F.

Somehow, NOAA has adjusted past temperatures down, relatively, by 1.8F.

Now, Homewood has given the same treatment to the most recent Big Freeze – the winter of 2017/2018.

Yet again, he has found that NOAA's arbitrary adjustments tell a lie. They claim that January 2018 was warmer in the New York region than January 1943, when the raw data from local stations tells us this just isn't true.

So at the three sites of Ithaca, Auburn and Geneva, we find that January 2018 was colder than January 1943 by 1.0, 1.7 and 1.3F respectively.

Yet NOAA say that the division was 2.1F warmer last month. NOAA's figure makes last month at least 3.1F warmer in comparison with 1943 than the actual station data warrants.

He concludes:

Clearly NOAA's highly homogenised and adjusted version of the Central Lakes temperature record bears no resemblance at all the the actual station data.

And if this one division is so badly in error, what confidence can there be that the rest of the US is any better?

Well indeed. The key point here is that while NOAA frequently makes these adjustments to the raw data, it has never offered a convincing explanation as to why they are necessary. Nor yet, how exactly their adjusted data provides a more accurate version of the truth than the original data.

One excuse NOAA's apologists make is that weather stations are subject to changing environmental conditions. For example, when the station sited at Syracuse in 1929 was located at what was originally just a sparse aerodrome. Since then, however, as Homewood notes, it has grown into a large international airport with two runways servicing two million passengers a year. Its weather station readings therefore will certainly have been corrupted by the Urban Heat Island effect: that is, its temperature readings will have been artificially elevated by the warmth from the surrounding development and aircraft engines.

So you'd think, wouldn't you, that to compensate for this NOAA would adjust the recent temperatures downwards. Instead, for no obvious reasons, it has adjusted them upwards. This is a scandal. NOAA's climate gatekeepers are political activists not honest scientists and the U.S. taxpayer has no business funding their propaganda.

TVA BOOSTING POWER OUTPUT AT BROWNS FERRY WITH \$475 MILLION UPGRADE

More than 2,100 TVA employees and contractors have started to install new equipment to boost the power output at the utility's oldest nuclear power plant by more than 14 percent.

Following a record-long 653-day run of power generation at the Browns Ferry Nuclear Power Plant, TVA idled the Unit 3 reactor at Browns Ferry over the holiday weekend and started Saturday to install equipment to add another 155 megawatts of generating power from the boiling water reactor.

Similar upgrades are planned on the two other units at Browns Ferry as part of a \$475 million program to boost overall power by 465 megawatts by the spring of 2019.

The extra power from the Extended Power Uprate, or EPU, is projected to produce enough additional electricity to power 280,000 more homes and will help TVA boost the share of power it gets from its nuclear power plants to 40 percent.

The power upgrade is far less costly than building new nuclear generation. TVA spent \$4.7

billion to add a 1,200 megawatt Unit 2 reactor at Watts Bar in 2016 — or more than \$3.9 million per installed megawatt — compared with only \$1.02 million per megawatt for the upgraded Browns Ferry units. At Plant Vogtle in Georgia, the new AP1000 reactors are projected to cost more than \$6.4 million per megawatt.

The upgrades at Browns Ferry are being done during scheduled refueling and maintenance outages. TVA spokesman Jim Hopson said that in addition to the traditional outage work of loading 344 new fuel assemblies, a final round of modifications will be installed that will boost the power generation on the Unit 3 reactor by this spring.

"Outages are always important because it's our opportunity to do the work necessary to safely and reliably generate electricity for the next two years," said Lang Hughes, Browns Ferry site vice president. "There is added importance to this and our next two outages because we will complete the remaining work needed to operate each unit at extended power uprate conditions to serve the energy needs of the Tennessee Valley."

More than 15,600 work activities are scheduled during this month's outage at Browns Ferry, including maintenance and upgrades of plant equipment, inspections and repairs on reactor components and installing modifications to improve safety margins.

The NRC has approved power uprates 163 times at U.S. commercial nuclear reactors, collectively adding an estimated 23,707 megawatts of generating capacity, according to figures compiled by the Nuclear Energy Institute, a trade group for the nuclear power industry. Equipment and technology advances have allowed reactors to be modified to


generate more steam and to use what steam they do produce to more efficiently generate more electricity, NEI spokesman Matt Wald said.

In 2006, the NRC approved 20-year license extensions for all three reactors at Browns Ferry beyond the original 40-year life of the license.

A GIANT CLAW WILL GRAB FALLING SPACEX GEAR 'LIKE A GIANT CATCHER'S MITT'

SpaceX is planning to use a giant net — one so immense that it takes up the majority of a high-speed watercraft named Mr. Steven — to catch reusable gear that falls back to Earth after missions to outer space.

If the huge net successfully catches the SpaceX gear, it could save the company about \$5 million per launch, according to Space.com, a Live Science sister site. [6 Ways Entrepreneur Elon Musk Is Changing the World]

"It's like a giant catcher's mitt, in boat form," SpaceX CEO Elon Musk told reporters after the Falcon Heavy launch on Feb. 6, Space.com reported.

In particular, the giant net is designed to catch the payload fairings, also known as the nose-cone halves. During the Feb. 6 mission, the payload fairings held the now-famous midnight-cherry Tesla Roadster and its driver, a mannequin known as Starman.

SpaceX has saved one of its payload fairings before: In March 2017, the company launched a previously used Falcon 9 rocket to carry a payload — a communications satellite designed to provide TV, internet and other services to people in Latin America. After that launch, the payload fairings used an onboard thruster system and a parachute to safely land in the Atlantic Ocean, Space.com reported.

However, the new net aboard Mr. Steven will make will make it easier for the payload fairing to be retrieved, according to TechCrunch.

According to SeaTran, the company that owns Mr. Steven, the vessel is 205 feet (62 meters) long, can travel up to 32 knots (36.8 mph, or about 59 km/h) and has a deck measuring 136 feet by 27 feet (41 by 8 m). It's not clear why the 2015 watercraft is named Mr. Steven (SeaTran didn't immediately respond to a request for comment), but other vessels in the company's fleet have similar names, including Lady Eve, Mr. Mason, Miss Claire and, amusingly, Greater Scott.

Mr. Steven is currently by Catalina Island, southwest of Los Angeles, according to MarineTraffic, a maritime site that tracks vessels around the world. You can see more images of it on Reddit.

The next SpaceX Falcon 9 mission is scheduled for Wednesday (Feb. 21). The payload fairing from that mission will have geotagged parachutes that will guide it to the Pacific Ocean, where Mr. Steven will attempt to catch it, according to TechCrunch.

ROBONAUT HAS BEEN BROKEN FOR YEARS, AND NOW NASA IS BRINGING IT HOME

In February of 2011, NASA launched Robonaut 2 to the International Space Station. It was a huge achievement for the robotics team at NASA's Johnson Space Center in Houston. There had been other robots in space, but Robonaut was the first advanced humanoid to ever go on a mission beyond Earth. On board the ISS, the robot was intended to eventually work side by side with astronauts, performing some of the dull and repetitive

tasks that take up a significant amount of time that the humans on the station could instead be spending on science and discovery.

For a while, things went well. The robot was unboxed from its protective foam packaging, and set up in the Destiny laboratory module. It was powered up for the first time in August of 2011, and by 2012 it was flipping practice switches and cleaning practice handrails while being teleoperated from the ground. Once a month or so, astronauts set Robonaut up and it would do research tasks for several hours at a



time, working towards making a transition from an experimental project to a useful helper in the caretaking of human spacecraft. Robonaut even got its own Twitter account: "Check me out. I'm in space!"

But in 2014, NASA decided to go forward with a complex and risky upgrade. The Robonaut sent to the ISS was a torso with a pair of arms and head, and now NASA wanted to add a pair of legs. The idea was to give Robonaut more mobility inside the station. The elongated, wiggly legs would work almost as a secondary pair of arms, allowing the robot to move itself around the station by holding on to hand rails, significantly adding to its capability.

But the upgrade didn't go according to plan, and instead created a persistent problem that astronauts have been unable to fix. For the last several years, Robonaut has been almost entirely disabled, and publicly available ISS status reports show that the last time the robot completed a full research task was December of 2013. This week, NASA announced that it is bringing Robonaut back to Earth to be fixed.

The decision to give Robonaut mobility had always been part of NASA's long-term plan for the robot. NASA originally intended for there to be three distinct phases of Robonaut operations. involved first phase stationary operations, and was completed successfully by the end of 2013 using the Robonaut Phase II was torso. vacuum outside of the station, although this scenario would have required even more major hardware upgrades to the robot.

"The space station program was interested in expanding our reach," Julia Badger, Robonaut Project Manager at NASA's Johnson Space Center, told IEEE Spectrum this week. "If we were able to move around, we could do logistics management, we could possibly clean filters, or do repairs. Moving around was the next level of capabilities that we'd be able to develop and test."

But adding new legs to the ISS Robonaut would be much more involved than simply shipping them up to the station and bolting them onto the Robonaut torso. The leg installation would require upgrading a significant amount of Robonaut's core hardware, including new computers and new wiring to interface the legs to the robot's main processor, not to mention a complex mechanical assembly process. Further complicating things was the fact that Robonaut was originally developed as a research robot for use on Earth. "Robonaut was not designed at all to be serviceable by astronauts," Badger said. "It was designed to be a lab robot, and we jumped at the opportunity to send it to space."

Even for NASA, the leg upgrade was ambitious. Asked if the team was confident it would work, Badger said: "I definitely don't think we were

confident. The ISS basically is about trying new things, so we learned a lot from developing those procedures and having the astronauts run through that complex surgery." She added that the crew members "did an outstanding job" and that the problem with the robot didn't involve what the astronauts did, but derived from the complexities of the hardware.

NASA expected that the leg upgrade, which took the Robonaut team 14 hours to do on Earth, would take the astronauts about 20 hours to complete. It ended up taking about 40. The work began on July 16, 2014, and was completed and called successful on August 28.

Almost immediately the Robonaut team at JSC

realized something was wrong. On August 29, the robot was partially powered up, but they weren't able to see any telemetry on the ground. Not long after, a loose wire was fixed and the robot passed intermediary checkouts, but during the next operation on December 17 (the first time motor power was applied to Robonaut after the upgrade), the legs wouldn't move.

Between January and August 2015, astronauts and ground teams recorded a series of erratic behaviors. including sensor failures. communication failures, and repeated processor September, lockups. By continued troubleshooting suggested that the issue was with the power supply to Robonaut's processors. "We would start losing power to our computers within our operational window, and it got more and more severe as time went on," Badger told us. "A power cycle would in general bring it back. just for a little while. The problem was that since it was intermittent, sometimes we'd be able to turn it on and sometimes it would just fail right away as it degraded, we weren't necessarily able to trust the data—it was very confusing."

David Wettergreen, a roboticist at Carnegie Mellon University, in Pittsburgh, who specializes in autonomous robots for planetary exploration, explained that the complexity of robotics



systems makes error detection and prevention a massive task. "For simpler systems it is reasonable to assume that everything will work, and when it does not, then it can be debugged and repaired, like your car," he said. "But if a robot won't be accessible, like an autonomous underwater vehicle, or if safety is paramount, like a self-driving car, then either all of the failure modes need to be understood and mitigated in advance or the robot needs to be able to diagnose and repair itself." To make things even more challenging, he added, techniques like fault tolerance and fault recovery are areas of substantial active research.

"Robonaut must be both robust and safe," he said, "so the systems engineering required is at the cutting-edge of technology."

The ISS daily summary reports provide a glimpse into how much both the astronauts on the station and the Robonaut team on the ground were struggling to understand what was going wrong with the robot. By 2016, it seems as though Robonaut was being taken apart and analyzed almost piece by piece.

[Astronaut Tim] Kopra set up a camcorder to capture standard definition video downlinks of Robonaut operations in the US Lab. He used the oscilloscope, multimeter and current probe to help guide ground teams with this troubleshooting by disengaging the controller card and successfully powering Robonaut without the controller card. The data collected

Two controller cards that the JSC team suspected could be the culprits were even shipped back to Earth for testing. But once inspected at the lab, the cards checked out okay, and the search for a fix continued, with the team checking and double-checking everything including the mass of cables inside the robot:

The crew performed troubleshooting on the Robonaut chassis. Previous troubleshooting suggested an issue with two card[s] that were returned and tested on the ground. The cards brought down were exonerated and during today's activities teams received a good response from the Robonaut during first power up. Indicator lights were as expected for a working Robonaut. Various power cycles were performed while trying to narrow down intermittent fault statuses. Eventually the team exonerated several of the cables. The cards were not removed from the CPCI [Compact Peripheral Component Interconnect] chassis and remain installed and all cables were left connected. Teams plan to analyze results to develop any forward actions.

It may seem surprising that NASA's robotics experts weren't able to diagnose and fix the problem more quickly, since space hardware is painstakingly designed, built, and tested before going into space. But the ISS Robonaut that the astronauts were working on is slightly different from the other five Robonauts at JSC. The space station Robonaut is an R2-B model, while the robots on Earth are R2-Cs, a later version that is "a fairly significant iteration of design," according to Badger. In the end, she said these differences finally provided the answer, years after the problem first appeared.

finding another path through, and it was slowly degrading the robot. Because that robot on orbit was different from the ones on the ground, it was kind of like a mistake that that ground path wasn't there, and it was very difficult to find."

Wettergreen, from CMU, said he's encountered similar scenarios. "Errors in properly grounding circuits can lead to really strange symptoms that initially appear unrelated to the root cause—seemingly anything can happen with the electronics," he said. "It can take a long time to debug because the problem is not easily reproducible and may not occur often,

or even in the same way every time."

Last August, astronauts tried to install a grounding jumper, but that didn't solve things. The place where they wanted to add the jumper, Badger explained, was covered in a special sealant used to protect sensitive components against shorts caused by foreign objects that can be floating around the ISS. The astronauts had to try to chip that away, and "there was a lot of difficulty," Badger said. "There was some doubt left on whether that was actually an effective connection or not. We're also quite confident that there's likely other damage that was caused by this missing wire."

It's this other damage that is the most concerning. Even if the original grounding issue has been solved, and the Robonaut team isn't sure it has been, Robonaut is almost certainly suffering from



significant degradation caused by current running unchecked through its computer chassis. There were some additional things the team could have tried, but when NASA asked if they wanted to use some free cargo space on the return flight of an upcoming resupply mission to bring Robonaut home, the team said yes. Depending on how much damage they find, the plan is to either repair the ISS Robonaut and send it back up to the station, or swap it for one of the R2-C units at JSC and send that one up instead.

Badger wasn't able to provide a timeframe for when Robonaut may be back on the ISS—there's no guaranteed mission, and they'll have to find space, which could be a challenge

since Robonaut is a relatively large payload. This means that they might not even be able to have the legs attached when they send it up for the second time, although Badger promises if that's the case, "it will be much, much simpler to reintegrate."

A few points need to be emphasized for those unfamiliar with the Broward County system. First, with revelations of frequent LEO contact and calls from people warning about school shooter Nikolas Cruz, there's a common narrative mistakenly being pushed by mainstream media.

This is not a "mistake" on their part, the 'doing nothing' is part of the standard practice.

* Secondly, the 27 minute tape-delay in the CCTV system is not an "accident", "flaw" or "mistake". It is entirely by design.

As a standard Broward and Miami-Dade practice, when school law enforcement need to cover-up or hide behavior, they need time (when that behavior happens) to delete the evidence trail. As such the school policy -as carried out in practice- is more efficient with a 30 minute tape delay affording the school officer enough time to deal with the situation, then erase the possibility of a recording of the unlawful activity surfacing.

Building in a 30 minute delay on the CCTV system was one of those pesky add-on items that happened a few years ago when the School and Law Enforcement officials established the policy of intentionally not arresting students.

With modern technology it's tough to hide criminal behavior, especially the violent stuff, when it is being recorded. Duh. Ergo the tape-delay was the best-practice workaround.

Lastly, when the county education policy is intentionally constructed to ignore criminal behavior in schools, the Sheriff and School superintendent cannot rely on "law-and-order-minded" school police officers to carry out the heavily nuanced policy. The county officials need the people closest to the work, the officers, to be able to think quickly on their feet to safequard their prized district-wide statistics.

2013 – Broward announced broad changes designed to mitigate the use of harsh punishments for minor misbehavior at the beginning of this school year. While other districts have amended their discipline codes, prohibited arrests in some circumstances, and developed alternatives to suspension, Broward was able to do all these things at once with the cooperation of a group that included a member of the local NAACP, a school board member, a public defender, a local sheriff, a state prosecutor, and several others. A Broward County SRO must carry a political hat and be able to intercept behavior, modify his/her action based on a specific policy need, falsify documents, hide evidence, manipulate records and engage inside the system with an understanding of the unwritten goals.

Broward County school law enforcement are given political instructions, and carrying out political objectives. They are not given law-enforcement instructions.

The school officers are the primary foot soldiers carrying out county political policy. Physical security of school students is not their role, they don't have time for that. The

Broward County SRO is in place to protect the school system "policy" and ensure students are not arrested for criminal conduct.

If you begin reviewing the downstream consequences with a correct understanding of the originating policy objectives then everything begins to make sense. Again, from the Miami Herald:

[...] on Nov. 30, an unidentified caller from Massachusetts called to say Cruz was collecting guns and knives. The caller said "Cruz will kill himself one day and believes he could be a school shooter in the making."

BSO, however, never even wrote a report on the tip. Internal affairs detectives are now trying to figure out what happened. Deputies Edward Eason and Guntis Treijs are on restricted duty while detectives examine their handling of the two potential school shooter tips. After the shooting, the tipster was re-interviewed and said BSO told him to report Cruz to the Palm Beach Sheriff's, as the teen was then living in the neighboring county. (read more)

Of course the Broward County Sheriff's Office didn't write a report. Writing a report would not be in line with the goals of hiding student criminal behavior.

Additionally, it seems odd to see the Miami Herald reporting on Nikolas Cruz in 2018; when the same editorial staff conspicuously avoided any aspects of Trayvon Martin's student criminal behavior in 2012 and 2013. I wonder why there's such a difference now?

[School Police Officer Scot] Peterson is mentioned as part of a 2016 social services agency investigation into Nikolas Cruz, the 19-year-old identified by police as the gunman. According to a Florida Department of Children and Families report detailing that investigation, Peterson was approached by investigators and "refused to share any information ... regarding [an] incident that took place with" the teenager.

That same year, the sheriff's office revealed Thursday, it was told about "third hand information" from a "neighbor's son" suggesting that Cruz "planned to shoot up the school," although the specific school was not listed. The sheriff's office said a deputy contacted the caller, determined that Cruz had knives and a BB gun and sent the information to the school resource officer — presumably Peterson. It is unclear whether he investigated. (Washington Post Link)

Feb. 5, 2016: A Broward Sheriff's Office deputy is told by an anonymous caller that Nikolas Cruz, then 17, had threatened on Instagram to shoot up his school and posted a photo of himself with guns. The information is forwarded to BSO Deputy Scot Peterson, a school resource officer at Marjory Stoneman Douglas High School.

Sept. 23, 2016: A "peer counselor" reports to Peterson that Cruz had possibly ingested gasoline in a suicide attempt, was cutting himself and wanted to buy a gun. A mental health counselor advises against involuntarily committing Cruz. The high school says it will conduct a threat assessment.

Sept. 28, 2016: An investigator for the Florida Department of Children and Families rules Cruz is stable, despite "fresh cuts" on his arms. His mother, Lynda Cruz, says in the past he wrote a racial slur against African Americans on his book bag and had recently talked of buying firearms.

Sept. 24, 2017: A YouTube user named "nikolas cruz" posts a comment stating he wants to become a "professional school shooter." The comment is reported to the FBI in Mississippi, which fails to make the connection to Cruz in South Florida.

Nov. 1, 2017: Katherine Blaine, Lynda Cruz's cousin, calls BSO to report that Nikolas Cruz had weapons and asks that police recover them. A "close family friend" agrees to take the firearms, according to BSO.

Nov. 29, 2017: The Palm Beach County family that took in Cruz after the death of his mother calls the Palm Beach Sheriff's Office to report a fight between him and their son, 22. A member of the family says that Cruz had threatened to "get his gun and come back" and that he has "put the gun to others' heads in the past." The family does not want him arrested once he calms down.

Nov. 30, 2017: A caller from Massachusetts calls BSO to report that Cruz is collecting guns and knives and could be a "school shooter in the making." A BSO deputy advises the caller to contact the Palm Beach sheriff.

Jan. 5, 2018: A caller to the FBI's tip line reports that Cruz has "a desire to kill people" and could potentially conduct a school shooting. The information is never passed on to the FBI's office in Miami.

Feb. 14, 2018: Nikolas Cruz attacks Stoneman Douglas High. Peterson, the school's resource officer, Scot Peterson, draws his gun outside the building where Cruz is shooting students and staff. He does not enter.

During the meeting with Parkland students at the White House on Wednesday President Trump said arming teachers is a step that can be taken to make schools less-attractive targets for attackers.

CNN quoted Trump saying, "Gun-free zone to a maniac—because they're all cowards—a gun-free zone is 'let's go in and let's attack because bullets aren't coming back at us." He said adopting a policy where "20 percent" of teachers were armed would reduce or eliminate the perception of weakness, making schools a riskier target to strike.

Trump said, "If you had a teacher who was adept with the firearm, they could end the attack very quickly."

Newsweek reports that Trump also emphasized mental health and raising "the minimum age for purchasing a firearm," but the push for arming teachers took center stage.

ISRAEL HAS ONLY HAD 2 SCHOOL ATTACKS IN 44 YEARS, HERE'S HOW THEY MAKE SURE THEIR KIDS ARE SAFE

In the wake of the Parkland, Florida, school shooting that claimed 17 lives last week, there has been a renewed debate surrounding gun control and children's safety, leading some to make a comparison to the changes Israel made in response to a terror attack more than four decades ago.

In 1974, Palestinian terrorists took over the Netiv Meir Elementary School in what has been called the "Ma'alot Massacre," which left 22 children dead and many others injured.

The attack forced Israel to come up with a solution in order to prevent such a situation from ever happening again. The nation requires its schools to have a security system, and that policy is still going strong after 40 years.

The results are clearly evident, as there have only been two successful attacks at Israeli schools since 1974, according to Dr. Ted Noel, writing in American Thinker. Noel wrote that "in both cases, the bad guys were killed by armed teachers."

According to Red State, Israel's Ministry of Education funds school security, which ranges from shelters and fences to armed and trained guards at every gate.

gunman does get through security by teaching them to be proactive in times of terror by barricading a door or sensing the ripe opportunity to get away safely.

The guards on the doorsteps of Israel's schools are also trained to look for any suspicious activity, which usually deters anyone with ill intent from entering in the first place.

That added layer of protection, argues Noel, is a proactive step in shielding children from the gunman. Once the shooters are past school gates, the damage is irreversible and quick to happen since any and all faculty and students immediately become targets.

"The Israelis saw this and got busy," Noel wrote. "They knew that the vast majority of terror attacks are stopped not by police, but by armed civilians."

"So they started training teachers in firearms use," he added. "Those teachers took out the bad guys in the two incidents since the Ma'alot Massacre."

Noel wrote that once a shooter is no longer in a "free fire zone," the situation — and the possible outcome — is likely to change, as he becomes a potential target.

"On top of that, he doesn't know which of the staff might be ready to shoot, or where they might be coming from," Noel said. "In short, only an idiot would try to shoot up a school with a trained staff of shooters."

This sentiment was echoed by CNN's Steve Cortes, who suggested that guns may not be the problem in the U.S. as much as America's lack of security when it comes to its children. Cortes compared Wednesday's shooting not just with Israel, but a disaster that didn't involve any bullets whatsoever.

"Since the awful Our Lady of the Angels elementary school fire of 1958, which killed 92 students and 3 nuns, there has not been a large casualty school fire in America," Cortes wrote. "Why? Because we took myriad precautions since then: better fire exits, more extinguishers and sprinklers, routine fire drills, etc."

"Water squelches a fire," he added. "And only a gunman, I would argue, can stop another gunman."

The recent conversation around gun control suggests that an added layer of protection would not only improve school security but also prevent the government from infringing on the Second Amendment, as well as prove that guns aren't necessarily the problem — people are.

Cortes added to this idea when he argued that stricter gun control laws have failed the world, as seen in the 2015 Paris Bataclan nightclub attack and numerous other incidents, as those who wish harm upon others will always find a way to do so.

"Evildoers, by definition, do not respect our rules and will find ways to skirt them," Cortes added, suggesting the only sure-fire way to combat these horrific acts is to improve school security and put America's children first.

"Let's value our children like the treasure they are and guard them accordingly," he said. "How? Let's start with key cards, fences, entry checks, biometric scanners, and — yes — armed guards, and a lot of them."

Chairman Mao: Every Communist must grasp the truth, "Political power grows out of the barrel of a gun." Our principle is that the Party commands the gun, and the gun must never be allowed to command the Party.

The American Version:

"The right to keep and bear arms shall not be infringed."

Hamilton, Federalist 29: Little more can reasonably be aimed at, with respect to the People at large, than to have them properly armed and equipped; and in order to see that this be not neglected, it will be necessary to assemble them once or twice in the course of a year. ... if circumstances should at any time oblige the government to form an army of any magnitude that army can never be formidable to the liberties of the People while there is a large body of citizens, little, if at all, inferior to them in discipline and the use of arms, who stand ready to defend their own rights and those of their fellow-citizens.

Madison, Federalist 46: "Besides the advantage of being armed, which the Americans possess over the People of almost every other nation, the existence of subordinate governments, to which the People are attached, and by which the militia officers are appointed, forms a barrier against the enterprises of ambition, more insurmountable than any which a simple government of any form can admit of"

The Framers recognized the truth of Mao's later statement - but wanted, insisted, ENSURED through the SECOND AMENDMENT that such power remain forever and always in the hands of the people at large.

And today's question for the snowflakes: Who do you want to command and control your life? A government that may not always be a benevolent friend - that in fact many of you insist is your greatest fear - or you, yourself? There are no other options. Be armed and free, or be the slave of whomever has arms after your arms are given up, or taken.
